

ProDIGIQ, Inc. Terms of Service Agreement

Last updated: September 10, 2008

The following Terms of Service Agreement (“Terms of Service Agreement” or “Agreement”) governs the use of the ProDIGIQ, Inc. online services and any content or information therein (the “Service”) and the prodigiq.com website along with such website pages on which the Service is provided (the “Site”) by ProDIGIQ, Inc. (“ProDIGIQ” or “us” or “we”). Please read the terms and conditions contained in this Agreement carefully. You can access the current version of this Agreement any time at Terms of Service. This Agreement may be modified from time to time and such modifications shall be effective immediately upon posting to the Site. The effective date of the then-current version of this Agreement will appear on this page. It is your responsibility to regularly check the Site to determine if there have been changes to this Terms of Service Agreement and to review such changes.

This Terms of Service Agreement applies to you if you are using the Service and even if you are only browsing or visiting the Site. By visiting the Site or using the Service, you agree to be legally bound by all of the terms of this Agreement, and ProDIGIQ’s Privacy Policy, which is incorporated herein by reference, including all changes and revisions to this Agreement and the Privacy Policy.
